- 1. The religious system leads cultured humans to have beliefs or beliefs that involve spiritual and spiritual elements in interacting in society that the highest culture is a culture of devotion to the creation of the universe. All nations and countries always exist as a created being given character, reason, awareness, instinct and ideas to understand this life with various intrigues of differences and similarities between humans.
- 2. The language system leads humans to know each other, understand, communicate, and work together in building a togetherness with mutual

- understanding according to the ability to capture messages on mutually understood language. Language is an instrument of cross-cultural civilization that must be understood in the context of interactive and productive communication to build important aspects of life.
- 3. The economic system delivers everyone to meet their needs, expectations and goals, so that there are intercultural relations based on the demands of more and less needs, relationships between producers and consumers, supply and demand relationships, patron and client relationships, as well as local, domestic trade relations. and international which all accumulate with the culture of each actor.
- 4. The technology system leads everyone to develop the technological potential that is owned as a result of an integrated and assimilated culture for the use and use of brilliant intellectuals in a creation that uses technical instruments, methods, analysis, synchronization and connectivity of various elements that have produced good assemblies. are software and hardware that are connected in a network system whether it is electronic, digitization, communication, application program and intelligent technology system.

- 3. Togetherness is an advantage possessed by someone who has local wisdom. Community life requires people who have the same fate, goals and aspirations. Narrow (2016) states that togetherness is the actualization of the behavior of people having personalities that are able to develop togetherness in achieving goals.

- 4. Trust is a personal belief that has been rooted in society in relation to aspects of obedience to the truth it believes in. Ambrado (2016) belief is the essence of a true belief in a wisdom value. Trust has a correlation with the wisdom that a person has. Trust is part of the local wisdom of a society which is actualized in the dynamics of life.
- 5. Self-esteem connotes an implementation of shame. Matulada (2014) states that uphold your self-esteem to cultivate self-wisdom. This means that in a person there is a self-esteem that has been ingrained between habits, actions and values that can foster one's wisdom. Self-respect means having an assessment of yourself that must be respected. Self-esteem is ashamed of things that deviate from self-esteem (self-existence).

The entire description emphasizes that cross-cultural management based on local wisdom is the main capital and asset for a country and nation to progress with its identity. That is why America, Japan and other developed European countries have always kept their cultural wisdom alive in the hearts of their people. Including Indonesia, at this time has realized the importance of local wisdom to always be grown in accordance with the culture that is rooted in society, from these differences as strength, uniqueness and power for a nation.
