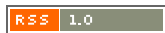
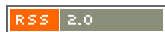

This shows that members of the youth organization are still less creative in terms of expressing ideas and also do not really understand their rights and obligations as members which of course will hinder their performance and work programs that will be less productive than the youth organization itself. So there is a need for a re-evaluation to find out the extent to which the program carried out by Karang Taruna is successful or improved.

The result of this problem is that the program being implemented is in the field of social welfare (society) which is not getting better for a long time. This is characterized by a lack of participation from youth and society. So they should get an explanation and guidance and direction so that they can take advantage of time for more useful things which will later make them a generation that is strong, skilled, moral and cautious and responsible and reliable in the midst of the people of the nation and the State has the surrounding environment. . This can be realized through a forum that is responsible for fostering them through youth organizations in rural areas. From the results of observations made by researchers in Suka Damai Village regarding existing problems, researchers found problems, namely according to the problems previously described. Then do on Youth in the village Suka Damai that the researcher took the initiative to steer young in Youth are to be able to run the work program they are then implemented so that it can be made as a solution for the local community. Previously Youth need to equip knowledge and ability in advance to the members to be driving.

Based on the problems, the researchers deeper reviewing entitled "Program Youth Copasus in the village Suka Damai Subdistrict Lemito Pohuwato", this is an important study done because then it will be known the nature of the real problem and in that way find ways to solve it properly.

RESEARCH METHODS

The approach used in this research is a phenomenological approach. The use of this method is based on the reason that the focus in this research is the form of the youth's daily life which is empowered through the Karang Taruna organization. Meanwhile, the phenomenological approach aims to describe the meaning of life experiences experienced by some individuals or youth about managing the Karang Taruna organization to build youth awareness. The phenomenological approach seeks to understand how humans construct important meanings and concepts within the framework of intersubjectivity (our understanding of the world is shaped by our relationships with other people (Kuswarno, 2009: 2) .

This type of research is a descriptive study with a qualitative approach. Bogdan and Taylor (Moloeng , 2007: 4) define qualitative research as a research procedure that produces descriptive data in the form of written or spoken words from people and observed behavior from the phenomena that occur. Furthermore, Moleong (2007: 11) argues that descriptive research emphasizes data in the form of words, pictures, and not numbers caused by the application of qualitative methods.

In obtaining data that is in accordance with the problem under study, the researcher uses the following data collection techniques:

1. Observation Technique

Observation is done by observing and seeing firsthand the phenomena that occur in accordance with the actual situation. Through observation, it can be obtained a clear direct picture of a social phenomenon that occurs in society.

Observations in this study were carried out directly to support the research being carried out. Researchers observe the interactions that occur between administrators and members in everyday life and activities of the Youth Organization in Suka Damai Village . Even though the observation is carried out directly, the researcher is outside the subject under study and is not directly involved in overall life observe.

2. Interview

Interviews are used in research to obtain information, information and explanations from research subjects. The interview consisted of questions related to the research being carried out. Researchers conducted semi-structured in-depth interviews using research instruments and allowed researchers to add questions to seek information from resource persons for the Karang Taruna management in Suka Damai Village, Lemito District, Pohuwato Regency. Before conducting the interview, the researcher first contacts the resource person to convey the aims and objectives of the researcher to the resource person. Then the researcher made an agreement with the resource person for face-to-face interviews. The interview was conducted at the resource's residence in Suka Damai Village, Lemito District, Pohuwato Regency.

3. Documentation

The documentation collected by researchers is in the form of secondary data, namely the documentation of the Karang Taruna activities because it is only used to complement and support the required data.

Data analysis in this study through 4 stages of activities that occur together, namely data collection, data reduction, data presentation, drawing conclusions or verification (Miles and Huberman, 1992: 15-21).

RESULTS AND DISCUSSION

Based on the results of observations or findings that can be put forward by researchers in this study about the Copasus Youth Organization Program in Suka Damai Village, Lemito District, Pohuwato Regency. M engacu on observation in this study as for the aspects that will be observed are as follows:

a. Conditions infrastructure

The condition of facilities and infrastructure in Karang Taruna can support the programs that will be run . Equipment provided by the Village Government such as lawn mowers , sports equipment and others . Of the amount is sufficient for Karang Taruna in implementing programs . But from the secretarial room or building that is not there yet to be used for the needs of the Youth Organization when they design the program they can use the secretariat.

b. Participation

The community and youth are always involved in running Karang Taruna programs. And their participation can also support the running of the program so that it requires contributions from the community and youth in implementing the Karang Taruna program both from energy and material. Because the community and youth are enthusiastic and involved when Karang Taruna makes Village activities.

c. Strategy to Achieve Program Goals

According to the researcher's observations, the Karang Taruna strategy to achieve the program objectives is that they always gather the community and provide socialization of the activities they will carry out. In addition, the Youth Organization will compile the programs that they will run.

d. Developments and Progress Program

The results of observations by researchers conducted, Karang Taruna in Suka Damai Village, namely that several years ago this organization did not run or was vacuum because the management already had their respective activities so that the program they were running did not progress. In 2017-2020, Karang Taruna has been running well and has development and progress towards the programs they run because many of its administrators are still students, so they are ready to participate in it to run the organization.

e. Results of the Youth Organization Program

The results of the researchers' observations regarding the results of the Karang Taruna program are that people can develop their creativity and especially their youth can develop their interests and talents through arts, sports, and diversity. Because with activities regarding sports, arts and diversity, they can hone their skills through the Karang Taruna activities.

RESULT AND DISCUSSION

This research was conducted in Suka Damai Village, Lemito District, Pohuwato Regency . The Youth Organization program has been around since 2013 . These Youth Organization programs are held to help the needs of the community and improve the welfare of the community . It is hoped that the Karang Taruna programs that are held can help the community and improve social welfare. The Karang Taruna Program has several programs that are in great demand by the people of Suka Damai Village and many people and youth help and participate in the Karang Taruna programs that are implemented. Youth and the number of members who are active in the activities that take that as many as 20 to late for the other members of Youth that they were study in the city of Gorontalo at several universities. The Karang Taruna program is held to help all groups of people and improve social welfare because the people of Desa Suka Damai are happy when Karang Taruna conducts activities in the village.

To illustrate the results of the program evaluation, the researcher made a schematic chart of the research results. This is done to evaluate the program that is carried out using the CIPP model (Context, Input, Process and Product). Program evaluation is carried out to assist evaluators in making decisions. Based on the results of the research , the youth youth program runs in accordance with the program objectives and the needs of the youth organization. Youth program in implemented which has a development d 's progress , because society and youth also always contribute to the youth programs, the village government has always supported the programs that coral cadets perform. And the coral program has achieved the program objectives in accordance with the vision and mission of the youth organization. The impact of the Karang Taruna program is to make the community and youth develop their creativity, the community is helped by the Karang Taruna organization in Suka Damai Village so that the Youth Organization can also improve welfare for the community.

DISCUSSION

1. Context Program Youth Copasus in the village Suka Damai

Context evaluation is carried out to find out how the program is implemented as planned with the needs of the Youth Organization, how the decisions that are designed can meet the program needs and the needs of the Youth

Organization. As well as how the goals set by the Village government are aligned with the objectives of the Youth Organization. Tayibnapis (2008: 14) states that context evaluation is to help plan decisions, determine needs to be achieved by the program and formulate program objectives. Context evaluation is carried out to find out how the program implemented is in accordance with the needs of the Youth Organization or not. And knowing what is the purpose of Karang Taruna in organizing programs.

In this context discussion, researchers will discuss program objectives and program suitability with the needs of the Youth Organization. The results of this discussion the researchers obtained through interviews, observations and documentation that the researchers did in the field.

a. Program Objectives

Goals are targets to be achieved. This objective will serve as a guideline for the Youth Organization which organizes the program so that in its implementation it can achieve these goals. The objectives in the program should be in line with the objectives set by the Village Government and the objectives to be achieved by Karang Taruna .

In the Karang Taruna program the objective of the Village Government is to awaken the souls of activists by the Karang Taruna management by having activities carried out . Meanwhile, the aim of the Youth Organization in implementing the program is to increase community creativity and establish friendship with the people of the Suka Damai Village, with the activities carried out by the Youth Organization.

The program organized by the Youth Organization aims to provide increased creativity to the community and youth so that people and youth can be more independent and develop their creativity . In addition, the objectives set by the Village Government are in accordance with the objectives of the Youth Organization . So that in its implementation, the organized program can achieve the goals set both by the Village Government and by the Youth Organization itself.

b. Suitability of the Program with the Needs of the Youth Organization

Programs that are right on target are programs that can meet the needs of the Youth Organization . Including the social welfare program , of course, it must be in accordance with the needs of the Youth Organization so that the needs of the Youth Organization in implementing the program can be met. The existing and desired conditions in the social welfare program held in Suka Damai Village are programs that can meet the needs of the Youth Organization and the interests of the members of the Youth Organization in helping to carry out the programs that are run .

Based on the research that the researchers did in the field, the program Youth held in the village of Suka Damai all the needs required by the Youth that all are met k arena implemented program has been based on the needs of the Youth of course it has been in accordance with the wishes and needs.

2. Input of the Copasus Youth Organization Program in the Peaceful Village

Input evaluation is an evaluation that is carried out on things that support the implementation process of the program. In evaluating the input, it assesses how existing resources can influence the implementation of the learning that is held. Tayibnapis (2008: 14) explains that input evaluation helps in managing decisions, determining existing sources, what alternatives are taken, what are the plans and strategies to achieve needs, and how are the procedures to achieve them. In evaluating this input, there are several components that support the implementation of a program. Widoyoko (2010: 182) explains that the input component includes human resources, supporting facilities and equipment, funds / budget, and various procedures and rules required in the program.

The input evaluation carried out in the Karang Taruna program in Suka Damai Village includes the number of Karang Taruna members, strategies to achieve program objectives, as well as existing facilities and infrastructure in Karang Taruna.

a. Members in Implementing the Program

One of the factors included in the program is the number of members of the Youth Organization in implementing the program . Members of the Youth Organization are one of the sources involved in the program, and as supporters in the implementation of a program. Karang Taruna has many members who can assist in the implementation of the program. The number of members in implementing the Karang Taruna program in Suka Damai Village is around 15-20 people who participate .

Based on the results of research conducted by researchers in the field, the level of contribution of members varies, starting from the number who participate in implementing the program and there are even members who do not contribute because some members are still studying at universities in Gorontalo so that some members do not contribute . Judging from the activities carried out by the Youth Organization, members who participate in the contribution are around 15-20 people and each activity implementation is supported by policies, procedures, and resources intended to bring a result to achieve the goals and objectives that have been set

b. Strategies for Achieving Program Goals

Strategy is a tool to achieve goals, in its development the concept of strategy must continue to develop and everyone has a different opinion or definition of strategy. A strategy in an organizational world is very much needed to achieve the vision and mission that has been implemented by the Youth Organization as well as for the achievement of goals or objectives, both short-term and long-term goals.

Based on the results of research conducted by researchers in the field, strategy is a tool to achieve goals by looking at external and internal factors in Karang Taruna. Strategies to achieve program objectives are looking at

internal factors, namely Karang Taruna must create work programs, manage programs, implement programs and evaluate programs. While the external factor, namely Karang Taruna, must provide socialization to the community about the activities to be carried out and know the rules in the village so that the program implemented does not violate the rules in the village.

c. Facilities and infrastructure

Facilities and infrastructure are supporting factors in the implementation of programs organized by Karang Taruna . The ingredients include equipment used in the program, such as sports equipment , print, laptop, ATK, Iqra / Al-Quran and tools grass trimmers and so forth. Meanwhile, infrastructure is the availability of places for program implementation, such as football fields, volleyball courts and so on.

The facilities and infrastructure in the Karang Taruna program in Suka Damai Village are in the form of a field used for sports , making activities that improve community welfare , and other activities.

Based on research conducted by researchers, in terms of the condition of facilities and infrastructure in Karang Taruna, it can be said to be quite good. The field and lawn mowers used are good enough, each field has a lot of grass and cannot be used in playing ball, so the grass will be mowed and treated. Although according to members there are many other facilities and infrastructure that can support the implementation of the program, namely those provided by the Village Government in accordance with the needs needed by Karang Taruna when carrying out its programs . In terms of the room provided by the Village Government, namely there is no Youth Organization secretariat , so that the secretariat is very important in organizations, especially the Youth Organization because when the Youth Organization will create a program, or destroy the program, and make a work program, Karang Taruna can use the secretariat.

3. Process Program Youth Copasus in Desa Suka Damai

Process evaluation according to Arikunto and Safruddin (2009: 47) refers to what activities are carried out in the program. Meanwhile, according to Tayibnapis (2008: 14), it explains that process evaluation is an effort to help implement decisions . The decision referred to here is the objective of the planned program. The evaluation of this process will explain about community and youth participation, successes and obstacles experienced in following the implemented program.

a. Community and Youth Participation

Community participation and youth in this regard include the contribution, participation and involvement in every program that is undertaken by the Youth both in the process of the activities that took place . Youth participation and yes it is very important in running the program for the Youth participation of the community and youth so that programs run by Youth can proceed smoothly and well. The following description of community participation and youth based on the research that the researchers did through interviews and observations.

According to the results of the study, the participation of the community and youth, namely the community and youth, strongly supports the programs carried out by the Youth Organization, this was expressed by the Village Head and the Karang Taruna administrators. And according to the results of the research, people's understanding of participation shows that they always play an active role and support the activities carried out by the Youth Organization and they also contribute in the form of energy and material.

Such as the results of research that the success in the program is seen from the success of all activities running smoothly and well because the community and the village government always support Karang Taruna activities and participate in them. Most of the obstacles are from funding or the lack of community members in carrying out ongoing activities because many other members and communities have their own busyness and other members are still studying in Gorontalo City.

Karang Taruna also feels an obstacle that cannot be denied, namely the lack of people involved in every Karang Taruna activities . So that there are some people who are not involved in carrying out activities. This has an impact to the Youth was send i ri so highly in needed her participation from members and the public but can not be denied because also have busy each and some members are also being study .

4. Product of the Youth Organization in Like Peace

Product evaluation is the process of assessing the success of a program that is implemented whether it is in accordance with the plan or not, and whether it has achieved the stated objectives or not. Arikunto and Safruddin (2009: 47) state that evaluation of products or results is directed at things that indicate changes that have occurred in raw inputs. Product evaluation is the final stage of a series of program evaluations. In this study, it will explain the achievement of the objectives set by the program, the development and progress of the program , and discuss the impact of the program that has been implemented.

a. Achievement of Program Objectives

Assessment of the success of a program can be seen from the achievement of program objectives. Whether the goals set have been achieved or not and how to achieve the objectives . Based on the results of research in the field, the objectives of the Karang Taruna program in Suka Damai Village have been achieved. And to achieve the goal, namely an approach to community leaders and the village government so that the program objectives can be achieved. In addition, the program run by the Youth Organization is able to make the people of Desa Suka Damai happy. The program has been running in accordance with the vision and mission set by Karang Taruna .

The vision of the Youth Organization, among others, is the realization of a young generation who are superior, independent, skilled, innovative, of character, religious, of quality and moral. The program that is carried out certainly has developments and advancements in accordance with the programs being implemented. Likewise, the Karang Taruna program which is held in Suka Damai Village, of course, has developments and progress towards the program it is implementing. c. Program Impact

The Youth Organization program held in Suka Damai Village has a strong influence on society and youth. community and youth feel the impact resulting from the Karang Taruna program that has been held in Desa Suka Damai. Based on the results of research conducted by researchers in the field, the impact of the Karang Taruna program held in Suka Damai Village is to make the community and youth develop their creativity, the community is helped by the organization of the Youth Organization in Suka Damai Village so that Karang Taruna can also improve welfare to society. Society and youth so they can develop new creativities that can increase knowledge.

Overall, from the evaluation of this product, the objectives that have been set by both the Youth Organization and the community and youth in the Karang Taruna program in particular to improve social welfare held in Suka Damai Village have been achieved.
