

AGREEMENT ON STUDENT EXCHANGE

BETWEEN

DONGSEO UNIVERSITY, KOREA

AND

GORONTALO STATE UNIVERSITY,
INDONESIA

Based on the Agreement between Dongseo University and Gorontalo State University, the two Universities have further agreed to this Agreement regarding an exchange program for undergraduate and graduate students.

1. Gorontalo State University can send no more than 3 (three) students per academic year to be admitted to study at Dongseo University based on the following conditions:
 - (1) Gorontalo State University will submit Dongseo University to applications for those students with the appropriate endorsement. Prior to the application, the coordinator of Gorontalo State University will contact the counterpart at Dongseo University to determine the courses to be taken, granting of credits, term of enrollment and advising (or supervising) university faculty members for the applicants. Final selection and approval will be made by Dongseo University based on the exchange student admission processes.
 - (2) Exchange students have the sufficient language ability (Korean or English) to be able to follow the course of study except for the Indonesian language students
 - (3) The term of enrollment shall commence at the beginning of either semester (first semester or second semester), and shall not continue more than one year or less than one semester.
2. Dongseo University can send no more than 3 (three) students per academic year to be admitted to study at Gorontalo State University, based on the following conditions:
 - (1) Dongseo University will submit Gorontalo State University applications for those students with the appropriate endorsement. Prior to the application, the coordinator of Dongseo University will contact the counterpart at Gorontalo State University to determine the courses to be taken, granting of credits, term of enrollment and advising (or supervising) university faculty members for the applicants. Final selection and approval will be made by Gorontalo State University based on the student exchange admission processes.
 - (2) Exchange students must have the sufficient language ability (Indonesian or English) to be able to follow the course of study except for the Korean language students.
 - (3) The term of enrollment shall commence at the beginning of either semester (first semester or second semester) and shall not continue more than one year or less than one semester.
3. The following conditions are applicable to exchange students of both Dongseo University and Gorontalo State University.
 - (1) Each university shall fully honor the credits and grades awarded by the other, and those credits and grades will be counted partially as requirements for graduation from the university based on its own system.
 - (2) Each exchange student shall pay regular tuition fees to his or her own university directly during


the period of the exchange. The host university shall charge no additional tuition including entrance and examination fees. However, costs of medical insurance are to be covered by the exchange students themselves.

- (3) The host University shall accept no financial responsibility for exchange students' round-trip travel expenses and costs for room and board, books, transportation and other incidentals. However, free accommodations may be offered to the students by the host university when the host university agrees to offer them.
- (4) Dongseo University and Gorontalo State University shall offer advice to the exchange students with respect to local arrangements, such as accommodation, board, and transportation.
4. It is intended that the number of exchange students participating from Dongseo University and from Gorontalo State University will be approximately the same.
5. Any difficulties or problems that arise in administering this Agreement shall be settled by the Presidents, or the Deans, or the Coordinators of the respective universities in mutual consultation.
6. This agreement will take effect when it is signed by the presidents of both universities, and it will be continued to be valid unless and until it is terminated by a written notice of any signatory party, or until three years has elapsed without successful interaction to the agreement.
